Introducing the *SuperSpeed USB 4-Port Hub*

The *SuperSpeed USB 4-Port Hub* is designed to support USB 3.0 equipped PC computers. This SuperSpeed USB hub expands USB 3.0 connectivity to your computer.

- Adds 4 more SuperSpeed USB (3.0) ports for all your USB 3.0 & 2.0 devices
- Supports ultra fast data rate up to 5 Gb/s (10 times faster than USB 2.0) and is backward compatible with USB 2.0 & 1.1 devices
- Over current protection built into each port to protect both connected devices and the hub itself from unforeseen power surges

- Windows® 7 (32-/64-bit) / Vista (32-/64-bit) / XP (32-/64-bit) / Server 2003 & 2008 (32-/64-bit)

Layout

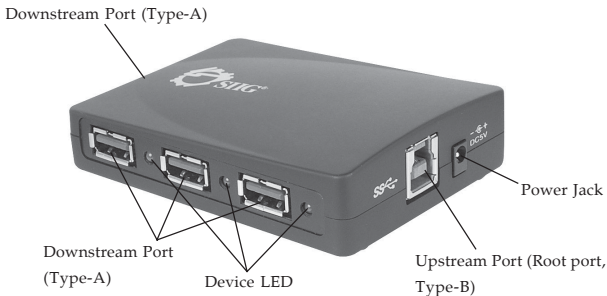


Figure 1: Layout

- **Device LED:** Lit when a USB device is connected, there is a **Device LED** for each downstream port

USB 3.0 Cable Connectors

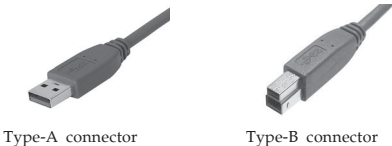


Figure 2: USB 3.0 Connectors

Installation

Important: The *SuperSpeed USB 4-Port Hub* only works at USB 3.0 speed when connected to a USB 3.0 controller. Otherwise it will work as a USB 2.0 or USB 1.1 hub when connected to USB 2.0 or USB 1.1 controller respectively.

In order for the *SuperSpeed USB 4-Port Hub* to work as a USB 3.0 hub, the driver for your existing USB 3.0 host controller has to be properly installed. This hub will automatically be detected and installed when connected to the USB 3.0 port.

1. Connect the **Type-B connector** of the included *USB 3.0 cable* to the **Upstream port (Root Port, Type-B)** of the *SuperSpeed USB 4-Port Hub*.
2. Connect the *Switching power adapter* into the **Power jack** of the *SuperSpeed USB 4-Port Hub*, then plug the power adapter into a reliable power source.

3. Plug the **Type-A connector** of the included *USB 3.0 cable* into an available USB port (USB 3.0 recommended), and the driver will install automatically.
4. The *SuperSpeed USB 4-Port Hub* is ready for use.

To Verify Successful Installation

1. Check in Device Manager to verify installation.
For Windows 7: Right click **Computer**, click **Manage**, click **Device Manager**.
For Windows Vista: Right click **Computer**, click **Manage**, click **Continue**, click **Device Manager**.
For Windows XP / Server 2003: Right click **My Computer**, click **Manage**, click **Device Manager**.
For Windows Server 2008: Right click **Computer**, click **Manage**, double click **Diagnostics**, click **Device Manager**.
2. Double click **Universal Serial Bus controllers**.
For Windows 7 / Vista / XP
With SuperSpeed USB (USB 3.0) host adapter: **NEC Electronics USB Hub** should be listed two times.
With Hi-Speed USB (USB 2.0) host adapter: **Generic USB Hub** should be listed.
For Windows Server 2003 / 2008: **Generic USB Hub** should be listed.
