Figure 1: 4-Port Industrial USB 3.0 Hub Layout




Figure 2: 7-Port Industrial USB 3.0 Hub Layout

Powering the Hub

The *Industrial USB 3.0 Hub with 15KV ESD Protection* requires a 9-24 VDC external power source (not included) to work. Power up the *Industrial Hub* through either the **DC Power Jack** or **3-Pin Terminal Block**.

DC Power Jack

Plug the power adapter into a reliable power source, then connect it to the hub's **DC Power Jack**. (Power adapter not included)





Figure 3: DC In





Figure 4: Power Terminal



Hardware Installation

Mount your hub on the wall or DIN-Rail, if needed.

DIN-Rail Mounting

1. Use the included screws to install the DIN-Rail kit to the hub.



2. Insert the top of the DIN-Rail clip onto the DIN-Rail track, then gently push the bottom of the hub to secure it to the DIN-Rail track. See **Figure 8**.

Use the provided Wall Mount Plate to mount the hub to the wall. See **Figure 9**.


