The FireWire PCI Adapter is designed to add FireWire (1394a) interface to your PC or Mac computer for easy connection to DV camcorders, hard disk drives (self-powered), scanners, printers, and other 1394 devices.

Layout




Figure 1: Layout

Hardware Installation

General instructions for installing the card are provided below. Since the design of computer cases and motherboards vary, refer to your computer's reference manual for further information, if needed. Static Electricity Discharge may permanently damage your system. Discharge any static electricity build up in your body by touching your computer case for a few seconds. Avoid any contact with internal parts and handle cards only by their external edges.

- 1. Turn OFF the power to your computer.
- 2. Unplug the power cord and remove your computer cover.
- 3. Remove the slot bracket from an available PCI slot.
- 4. Carefully align the card to the selected PCI slot push the board down firmly, but gently, until it is well seated.
- 5. Replace the slot bracket holding screw to secure the card.
- 6. Replace the computer cover and reconnect the power cord.

Driver Installation

Please make sure the board is installed before proceeding with driver installation.

Windows 8 / 7 / Vista / XP / Server 2003 & 2008 / Server 2008 R2 / 2000

Windows 8, 7, Vista, XP Server 2003 & 2008, Server 2008 R2 and 2000 will automatically detect and install the correct driver for the *FireWire PCI Adapter*. No additional driver is needed.

Windows ME

- At the Add New Hardware Wizard, choose Automatic search for a better driver (Recommended), then click Next.
- 2. Click **Finish** and restart Windows to complete the driver installation.

Windows 98SE

- When Windows boots up, a New Hardware Found dialog box should appear and the OHCI Compliant IEEE 1394 Host Controller is identified.
- 2. At the **Add New Hardware Wizard**, click **Next**.
- 3. Choose **Search for the best driver for your device**, and click **Next**.
- 4. Clear all check boxes, click **Next**, **Next**, and **Next**.

NOTE: If prompted for the *Windows 98SE* CD, insert it, then click **OK**.

5. Click **Finish** to complete the driver installation.

Verify Windows Installation

1. Check **Device Manager** to verify successful driver installation.

<u>Windows 8 / 7 / XP / Server 2003 / 2000</u>: Right click **Computer** or **My Computer**, then click **Manage**. Click **Device Manager**.

<u>Windows Vista:</u> Right click **Computer**, click **Manage**, click **Continue**, then click **Device Manager**.

<u>Windows Server 2008 / 2008 R2</u>: Right click **My Computer**, then click **Manage**, double click **Diagnostics**. Click **Device Manager**.

<u>Windows 98SE / ME</u>: From the main desktop, right click **My Computer**, then click **Properties**. Click **Device Manager** tab.

Double click 1394 Bus Controller or IEEE 1394
 Bus host controllers option. An IEEE 1394
 Host Controller should be displayed.

Mac OS Installation

To ensure proper operation, some Mac OS require the most current FireWire software from Apple. Apple's website contains all the information needed to download and install FireWire software update. The information below will help you decide whether or not to download and install the latest FireWire driver update.

- Mac OS 9.1, 9.2.x, and Mac OS X or later have built-in FireWire driver support with the operating system. No additional driver installation is needed.
- 2. **Mac OS 9.0.x** users should download and install the FireWire software update version 2.5 or later.
- 3. **Mac OS 8.6** users should download and install the FireWire software update version 2.3.3.
