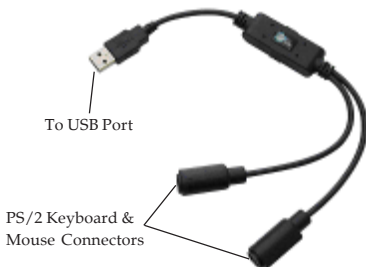

## Hardware Installation

1. Power off your system if it is on.
2. Connect the PS/2 keyboard and/or mouse to the appropriate PS/2 connector.
3. Connect the USB connector to your system's USB port and power on your system.

## Windows 98/98SE

1. At the **Add New Hardware Wizard**, click **Next**.
2. Choose **Search for the best driver...** and click **Next**.
3. Clear all check boxes and click **Next**.
4. Click **Next** and **Finish**.
5. **In Windows 98**, repeat steps 1-4 two more times. **In Windows 98SE**, repeat steps 1-4 one more time.

## **Windows ME/2000/XP/Server 2003/Vista**

The drivers are built-in with Windows ME, 2000, XP, Server 2003 and Windows Vista™ operating system. Simply connect the *USB-to-PS/2 Adapter* to an available USB port and the drivers will install automatically.

## **Mac OS 9.0 or later**

The drivers are built-in with Mac OS 9.0 or later. Simply connect the *USB-to-PS/2 Adapter* to an available USB port and the drivers will install automatically.
