Layout




Figure 1: Back Layout

- HDMI In: HDMI input source
- HDMI Out: Distributed HDMI outputs
- USB In: For firmware update use only
- **Power Indicator**: When power on, the LED will blink
- **DC In**: 5V 2A

Note: When the connected HDMI equipped monitor is verified as HDMI and HDCP compliant, the corresponding green LED will blink.

Hardware Installation

Broadcasts HDMI signal to 4 HDMI displays

- 1. Switch off all devices, including monitors.
- 2. Connect the LCD(s) to the HDMI Out(s).
- 3. Connect an HDMI source (such as a Blu-ray Disc player) to the HDMI In.
- 4. Plug in 5V DC power supply.
- 5. Power on the HDMI monitors.
- 6. Power on the HDMI source.
