### Windows 7/Vista/XP/Server 2003 & 2008/2000/ME

The drivers are built-in with Windows. Simply connect the *USB-to-PS/2 Adapter* to an available USB port and the drivers will install automatically.

### Windows 98/98SE

1. At the **Add New Hardware Wizard**, click **Next**.
2. Choose **Search for the best driver...** and click **Next**.
3. Clear all check boxes and click **Next**.
4. Click **Next** and **Finish**.
5. Repeat steps 1-4 several more times.
