## Layout

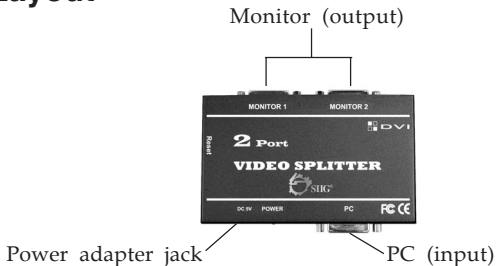


Figure 1: 1x2 DVI Splitter Layout

## Hardware Installation

---

1. Power off the computer and monitors you plan to connect to this splitter.
2. Connect your computer's DVI out to the splitter's **PC** connector using a DVI cable (not included).
3. Connect your monitors to the splitter's **Monitor** connectors using DVI cables (not included).
4. Connect the splitter's power adapter.
5. Turn on the monitors, then computer.
6. The *1x2 DVI Splitter* is now ready to use.
