Layout




Figure 1: Layout

- HDMI Input: Connects to HDMI source's HDMI output
- HDMI Outputs (1-8): Connects to your HDMI displays
- Power adapter jack: Connects to the included power adapter
- On/Off switch: Powers on & off the splitter
- Power: LED is lit when the splitter is powered on
- Reset: Resets the splitter

Hardware Installation

- 1. Power off all devices you plan to connect to this splitter.
- 2. Connect your HDMI source's HDMI out to the splitter's **HDMI Input** using an HDMI cable (not included).
- 3. Connect your monitors to the splitter's **HDMI Output** using HDMI cables (not included).
- 4. Connect the included power adapter to the splitter's power jack and plug it into a reliable power outlet.
- 5. Power on the splitter.
- 6. Power on all of the connected devices.
- 7. The splitter is now ready to use.
