Layout

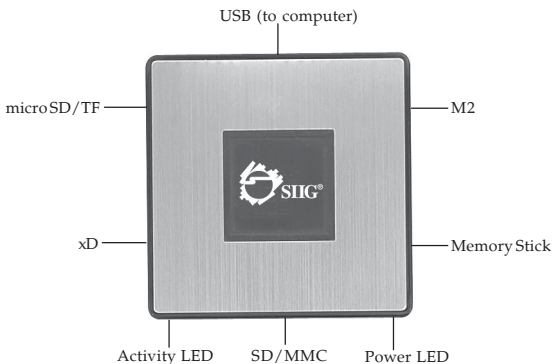


Figure 1: Layout

Installation

Windows and Mac OS automatically detects and installs the correct driver for this reader/writer when connected. No driver installation is needed.

Inserting Memory Cards

Insert all memory cards with the gold pins forward and facing down. **Caution:** Only one memory card can be inserted at any one time.

Using your Memory Cards

Windows

When the reader/writer is successfully installed, one additional disk icon will appear in **Computer** or **My Computer**. Double click the appropriate disk icon to access the memory card. **Note:** In Windows 7 & 2008 R2, the disk icon will appear after a memory card is inserted into the reader/writer. To prevent data corruption or loss, do not remove memory card while the Activity LED is flashing.

Mac

After a memory card is inserted into the reader/writer, a disk icon will appear on the desktop. Double click the appropriate disk icon to access the memory card. To remove a memory card, drag its drive icon into the Trashcan. Wait for the icon to disappear from the desktop before removing it.
