Hardware Installation

- 1. Power off all devices connecting to splitter.
- 2. Connect the splitter's **VGA IN** to the computer's VGA port.
- 3. Connect the splitter's **3.5mm Audio Plug** to the computer's audio out jack (optional).
- 4. Connect the splitter's **USB Type A** connector to the computer's USB port for power.
- 5. Connect your VGA monitors to the splitter's **MONITOR** Ports*.

***IMPORTANT**: A monitor must be connected to Monitor 1 port if you are connecting less than 4 monitors.

- 6. Connect your speakers to the splitter's Speaker jack (optional).
- 7. Turn on the monitors, then the computer.
- 8. The 1x4 VGA & Audio Splitter is now ready to use.
