Hardware Installation

- 1. Power off all devices you plan to connect to this converter.
- 2. Connect your audio source to the converter's **Input** connector using a R/L cable (not included).
- 3. Connect your A/V receiver or amplifier to the converter's **Output** connectors using a Toslink or Coaxial cable (not included).
- 4. Connect the converter's power adapter.
- 5. Turn on the A/V receiver or amplifier, then the audio source.
- 6. The *Analog to Digital Audio Converter* is now ready to use.
