The *DVI to Mini DisplayPort Converter with Audio* allows you to convert DVI video and stereo audio signals into standard Mini DisplayPort signal.

Layout

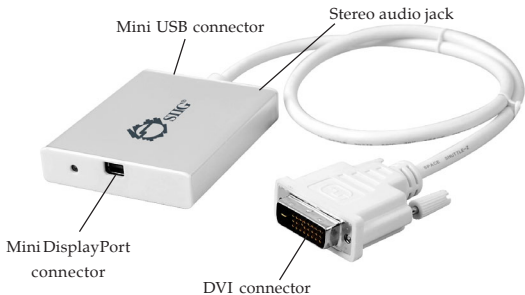


Figure 1: Layout

Hardware Installation

1. Power off all devices you plan to connect to this converter.
2. Connect the converter's Mini DisplayPort connector to your monitor using the included Mini DisplayPort (M) to Mini DisplayPort (M) cable.
3. Plug the converter's DVI connector, Mini USB connector and stereo audio jack into the respective ports of the computer using the included cables.
4. Turn on the display, then the computer.
5. The *DVI to Mini DisplayPort Converter with Audio* is now ready to use.

Note: In order for this converter to work properly, the source device and the monitor must support the same resolutions.

Application Diagram

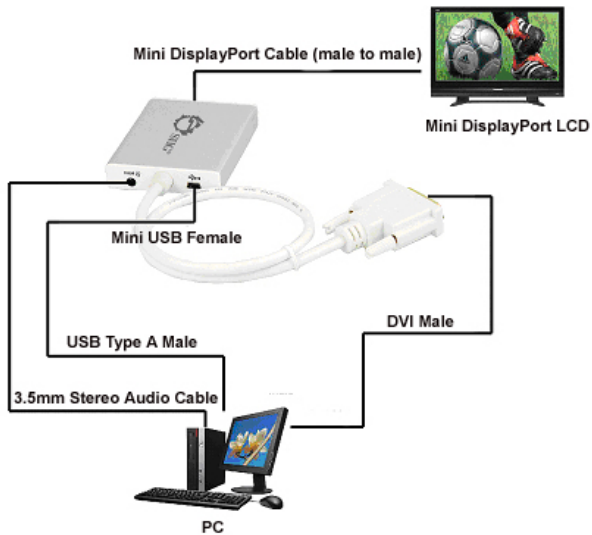


Figure 2: Application Diagram
