


Figure 1: Layout

Hardware Installation

- 1. Power OFF all devices you plan to connect to this switch.
- Connect your S/PDIF TOSLINK audio source(s) to the switch's Optical In(s) using TOSLINK Optical cable(s) (cable(s) not included).
- 3. Connect your S/PDIF TOSLINK audio receiver, amplifier or speaker to the switch's Optical Out using a TOSLINK Optical cable (cable not included).
- 4. Connect the included power adapter to the switch's power jack, then plug the power adapter into a reliable power outlet.
- 5. Power on all devices, the switch is ready for use.
- 6. Use the **Audio Source Select Switch** to switch between your audio source devices.
