


Figure 1: Layout

Hardware Installation

- 1. Power OFF all devices you plan to connect to this converter.
- 2. Connect your audio source(s) to the converter's Optical In or Coaxial In using the respective cable(s) (cable(s) not included).
- 3. Connect your audio receiver, amplifier or speaker to the converter's Optical Out or Coaxial Out using the respective cable(s) (cable(s) not included).
- 4. Switch either Coaxial or Optical to match your audio source.
- 5. Connect the included power adapter to the converter's power jack, then plug the power adapter into a reliable power outlet.
- 6. Power on all devices, the converter is ready for use.
