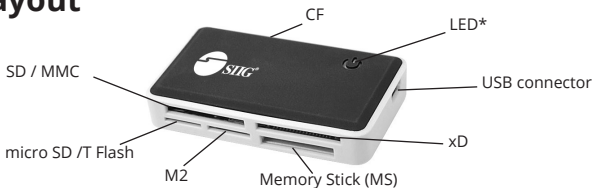

- Memory Stick (Pro, Duo, Pro Duo, etc) / M2 (MS Micro) / Micro SD / T Flash / CF

Insert memory card with the top label facing up.

- SD / SDHC / MMC / xD
