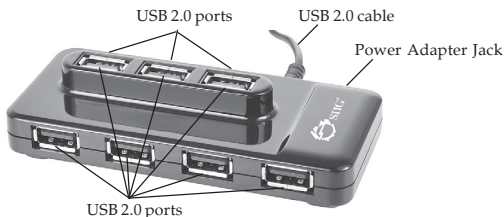


Figure 1: Layout

**Important:** This hub only operates at USB 2.0 speed when connected to a USB 2.0 controller. Otherwise, it will operate as a USB 1.1 hub when connected to a USB 1.1 controller.

Windows and Mac will automatically install the correct driver when plugged into the computer. No additional driver installation is needed.
