This industrial-grade USB 2.0 hub expands 1 USB port into multiple high-efficient USB 2.0 ports. Designed for industrial usage and tough working environments, this hub comes in a rugged metal housing with wall mount and din rail mount capabilities.

4-Port Industrial Grade USB Hub



Powering the Hub

The hub may require an external power source to work properly. Use either an external 5V DC power adapter (not included) or selectable 9V to 36V DC output, and connect it to the hub's **DC Power Jack** or **3-Pin Terminal Block** respectively.

DC Power Jack

Plug the power adapter into a reliable power source then connect it to the hub's DC Power Jack.




Figure 3: DC In

3-Pin Terminal Block




Figure 4: Power Terminal

Plug the included terminal block into the hub's terminal block connector. See **Figure 4** and **Figure 5**.



Hardware Installation

Mount your hub on the wall or DIN-Rail, if needed.

DIN-Rail Mounting

1. Use the included screws to install the DIN-Rail kit to the hub.



2. Insert the top of the DIN-Rail clip onto the DIN-Rail track, then gently push the bottom of the hub to secure it to the DIN-Rail track.


