Installation Guide

Introduction

The *USB Stereo Audio Adapter for 4-Pole Headset* is a simple Plug-n-play device that allows mobile headsets to work with PCs.

Requirements

- Windows® 8 (32-/64-bit) / 7 (32-/64-bit) / Vista(32-/64-bit) / XP (32-/64-bit) / Server 2003 & 2008 (32-/64-bit) / Server 2008 R2
- Mac OS®X v10.4 or later
- Windows or Mac system with an available USB port
- Mobile Headsets

NOTE: Not suitable for NOKIA and SONY previous headsets

Layout

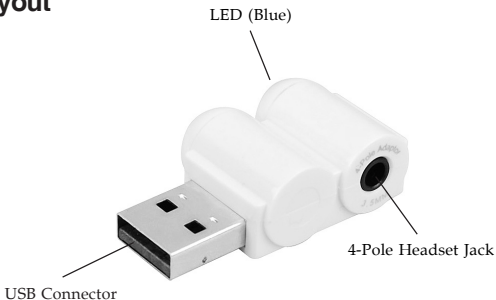


Figure 2: Layout

- **USB Connector:** Plug into a USB port
- **4-Pole Headset Jack:** Connect your mobile headset here
- **LED:** Power On (Blue) & In Use (flashing)

Installation

1. Plug this adapter into your system's USB port (Type-A) and the driver will load automatically.
2. The audio adapter is ready to use.

To Verify Successful Installation in Windows OS

1. Right click **Computer** or **My Computer**, click **Manage**.

For Windows 8 / 7 / XP / Server 2003 / 2008 R2: Click **Device Manager**.

For Windows Vista: Click **Continue**, click **Device Manager**.

For Server 2008 : Double click **Diagnostics**, click **Device Manager**.

2. Double click **Sound, video and game controllers**. **USB PnP Sound Device** or **USB Audio Device** should be listed.

To Verify Successful Installation in Mac OS

1. Check in **System Preferences**.
2. Choose **Sound**
3. **USB PnP Sound Device** should be listed.

Changing the Sampling Rate

To Change the Sampling Rate in Windows OS

1. Open **Control Panel**, click **Sound**. **USB PnP Sound Device** should be listed.
2. Double click the icon, under the **Speaker Properties** window, choose the **Advanced** tab, the current sampling rate will be displayed.
3. Click the drop-down list to change the sampling rate.
4. Click **Apply** to save the changes or click **OK** to apply changes and close the **Speaker Properties** window.

NOTE: Changing sampling rate only works in Vista or later.

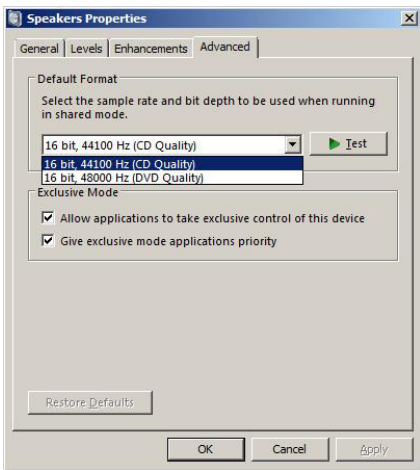


Figure 3: Changing the Sampling Rate in Window OS

To Change the Sampling Rate in Mac OS

1. Open the **Applications** folder, choose **Utilities**, choose **Audio MIDI Setup**.
2. Select the listed **USB PnP Sound Device**.
3. Click the drop-down list to change the sampling rate.
4. Once the sample rate has been changed, the current sampling rate will be reflected on the front panel of the Audio Decoder.

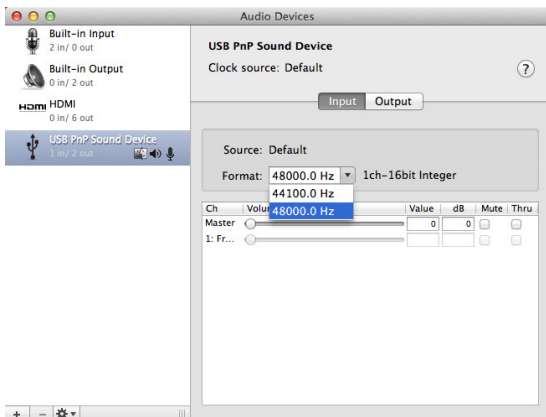


Figure 4: Changing the Sampling Rate in Mac OS
