- HDMI (Male): Connects to the HDMI port of your HDMI display
- Display resolution: Indicates the display resolution of your HDMI display
- HDCP version: Indicates the HDCP version of your HDMI display
- Micro-USB (Female): Powers the tester Connects to the included Micro-USB to USB power cable. Plug the other end of the power cable into a USB power charger or your computer's USB port
- Color depth: Indicates the color depth by your HDMI monitor or TV
- Color space: Indicates the color space of your HDMI monitor or TV
