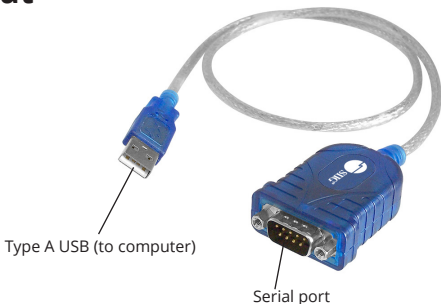


Figure 1: Layout

Windows Installation

Make sure the driver is installed **before** plugging the *USB to Serial Adapter Cable* into the computer. **Do Not** plug the *USB to Serial Adapter Cable* into the computer until instructed to do so.

Windows 8 (32/64-bit) / 7 (32/64-bit) / Server 2008 R2

1. At the Windows desktop insert the driver CD. Close the CD autoplay box if prompted.
2. Click **Windows** key and **R** key, type **D:\setup.exe**, then press **Enter**. (Change **D:** to match your CD-ROM drive letter)
3. At User Account Control, click **Yes**. For Server 2008 R2, skip this step.
4. At Welcome to the InstallShield Wizard for PL-2303 USB to Serial, click **Next**, then click **Finish**.
5. Plug the *USB to Serial Adapter Cable* into a USB port and the driver will install automatically.
6. Restart Windows to complete the installation.

Windows Vista (32/64-bit) / XP (32/64-bit) / Server 2003 & 2008 (32/64-bit) / 2000

1. At the Windows desktop insert the driver CD.
2. At the CD autoplay window: Double click the **setup** file in the driver CD.
If the CD autoplay window does not start:
Click **Start**, and **Run**, type **D:\setup.exe**, then press **Enter**. (Change **D:** to match your CD-ROM drive letter)
3. At User Account Control, click **Allow**. Skip this step if not prompted.
4. At Welcome to the InstallShield Wizard for PL-2303 USB to Serial, click **Next**, then click **Finish**.
5. Plug the *USB to Serial Adapter Cable* into a USB port and the driver will install automatically.
6. Restart Windows to complete the installation.

To Verify Windows Installation

1. Check **Device Manager** to verify installation.
For Windows 8 / 7: Right click **Computer**, click **Manage**, then click **Device Manager**.
For Windows Vista: Right click **Computer**, click **Manage**, click **Continue**, then click **Device Manager**.
For Server 2008 / 2008 R2: Right click **Computer**, click **Manage**, double click **Diagnostics**, then click **Device Manager**.
For Windows XP / Server 2003 / 2000: Right click **My Computer**, click **Manage**, then click **Device Manager**.
2. Double click **Ports (COM & LPT)**, a **Prolific USB-to-Serial Comm Port...** should be displayed.
