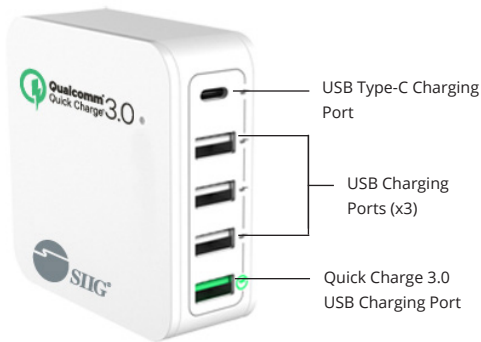

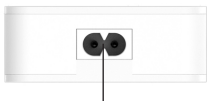

- **USB Charging Ports (x3):** Connects to smartphones, tablets or other USB powered devices for charging
- **Quick Charge 3.0 USB Charging Port:** Connects to smartphones, tablets or other USB-powered devices for charging



2-pin power connector

- **2-pin power connector:** Connects to the included power cord for power source

## Instructions for Use

### **Note:**

1. It is recommended to use your USB device's original charging cable for charging.
2. For *Quick Charge 3.0*, please make sure to use the device's **Sync & Charge** USB charging cable for proper initialization.

1. Connect the *Charger* to a reliable power outlet using the included power cord and verify the power LED is lit.



2. Connect your USB device(s) to the USB charging ports using USB charging cable(s).

**Note:** Plug your *Quick Charge 3.0* enabled device into the **Quick Charge 3.0 USB Charging Port** for optimal charging efficiency.



3. Optional: Use the included charging organizer as needed.
