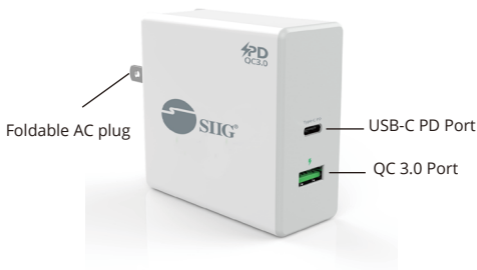


Figure 1: Layout
